



## NOTICE OF COMMENCEMENT AND PUBLIC INFORMATION CENTRES

### The Study

Dundas Street is changing. Over the next 35 to 40 years, the number of people who live, work, learn, and travel along the corridor is expected to increase. To manage this growth, the City is developing a Master Plan for Dundas Street. The Master Plan will make recommendations on what Mississauga can do to manage this growth, including how best to direct development and intensification, what kind of rapid transit Dundas should have, and how public space should change in order to create the street that Mississauga needs. The Master Plan will cover the entirety of Dundas Street within the City of Mississauga.

### The Process

The Master Plan study will be conducted in compliance with the Municipal Engineers Association “Municipal Class Environmental Assessment” (October 2000) updated in 2007, 2011 and 2015, which will address Phases 1 and 2 of the Municipal Class Environmental Assessment (EA) process.

### Phase Two Consultations

As part of the study, four Public Information Centres (PICs) are planned to present and seek feedback on different ways that the City of Mississauga can manage the projected growth in people and jobs along Dundas Street.

You are encouraged to attend the PICs and provide your comments. Comments received through the course of the study will be considered in finalizing the Master Plan, and will assist the City in meeting the requirements of the EA process. Information will be collected in accordance with the Municipal Freedom of Information and Protection of Privacy Act. With the exception of personal information, all comments will become part of the public record.
